Chief Wolf is proposing to use the income from his wildland fire deployments to pay the department members for shifts they did while deployed on the fires. Amount to be determined by total income and total fire shifts done. Jon Hodde noted his conflict as his wife, Megan Hodde, was deployed on the fires, but he supports supporting the department members.

Motion by Larry Learning, seconded by Mike Richardson to approve compensation to the members for shifts not to exceed amount billed for Chief Wolfs deployments. Motion carried unanimously.

<u>Treasurer's Report</u>- Jon Hodde reviewed the September 2020 balance sheet(s) including, but not limited to: governmental funds and schedule of capital assets, statement of revenues, expenditures, and changes in fund balance for general operations, operating reserve, Tabor and capital reserve were also provided. Sales tax projections were discussed. Moved by Larry Leaming, seconded by Mike Richardson to accept paid bills. Motion carried unanimously.

# **OLD BUSINESS**

# **Extension of Disaster Declaration**

While we are operating under a disaster declaration the board needs to formally extend the order at each board meeting.

Motion by Jon Hodde, seconded by Mike Richardson to extend resolution 20-02 continuation of declaration of local disaster emergency. Motion carried unanimously.

# 2021 Proposed Budget

Chief Wolf again presented the proposed 2021 budget with no significant changes since the last presentation. There were no questions or discussion from the board.

# **NEW BUSINESS**

# **Active Membership Policy**

Chief Wolf presented to the board the active membership policy and how COVID has affected our call volume. Paged calls are down 25%, therefore Chief Wolf proposes a modification of 75% of target to be in good standing for the year of 2020. This will be written up and brought to the board for formal review on 11/11/2020 and then for approval on 11/25/2020.

### Fee Waiver Request - CDOT Facility

Chief Wolf presented to the board the request for a fee waiver by CDOT for a facility on Elm Road. Chief Sullivan submitted a letter showing support for a reduction but not a full waiver of fees. The board discussed what has been done in the past and if this fit within the scope of our policy.

Motion by Mike Richardson, seconded by Larry Learning to support Chief Sullivan's recommendation of retaining the plan review fee of \$500 and 50% reduction of the impact fee. Motion carried unanimously.

# **Board Vacancy**

Dave Coleson resigned from the board effective 10/19/2020. There are three people who have expressed interest in the position, Dave Hamrick, Randy Brigham, Doug Klink. This position will be filled by appointment and go until the next election in 2022. All three prospective board members introduced themselves and gave a brief background of experience to the board. Lt. William Harkins asked what the process is. Jon Hodde expressed a desire to fill the vacancy soon and to not delay. Mike Richardson expressed that he feels they should have a connection to the department so they can maintain connection to the membership. Larry Leaming voiced that having too many people on the board with an operations background is a disadvantage. That the board needs to represent the community and needs to be visionary. The board encouraged the membership to get to know the candidates and provide feedback. Erika Goetz to send an email to the membership and provide contact information for the candidates. Erika is to collect feedback from the membership and provide that to the board. The board intends to fill the vacancy at a board meeting on November 11<sup>th</sup>.

### **Resolution 2020-04 Wildfire Disaster Declaration**

Chief Wolf signed an emergency declaration for wildfires on October 23<sup>rd</sup>, 2020. This declaration needs to be approved by the board within 7 days.

Motion by Larry Learning, seconded by Mike Richardson to approve resolution 2020-04 for Wildfire Disaster Declaration. Motion carried unanimously.

Chief Wolf expressed that many outside agencies have had high praise for our department and membership.

President Ed Ford thanked the staff and membership for everything they have done these past few weeks.
