PUBLIC COMMENT / BOARD COMMENT

Frank Theis who is a part of the builders advisory committee wanted to say a few things on behalf of the builders. Contractors in town are facing worker shortages, rising prices for materials, and material shortages. He is asking that we show some flexibility and kindness while dealing with these issues. He also wanted to point out that there seems to be some communication issues or breakdown in the permit process between Larimer County and the EVFPD. Chief Wolf acknowledged the issues and that we have been working to rectify them.

On behalf of the Estes Valley Watershed Coalition; Frank Theis informed us that they are working to update the Community Wildfire Protection Plan (CWPP). They are working with the Town of Estes Park and Larimer County to help fund this project.

Extension of COVID-19 Disaster Declaration

While we are operating under a disaster declaration the board needs to formally extend the order at each board meeting.

Motion by Ed Ford, seconded by Jon Hodde to extend resolution 20-02 continuation of declaration of local disaster emergency. Motion carried unanimously.

Second Review of Update to Policy #301 - Active Membership Policy

Motion by Larry Learning, seconded by Dave Hamrick to approve the update to policy #301 – Active Membership Policy. Motion carried unanimously.

Second Review of Update to Policy #305 – Emergency Driving Policy

No changes from first review.

Motion by Dave Hamrick, seconded by Ed Ford to approve the update to policy #305 – Emergency Driving Policy. Motion carried unanimously.

MOU – Restorative Justice Program

Chief Wolf presented to the board a MOU between the Town of Estes Park and EVFPD to utilize the Estes Valley Restorative Justice Partnership on an as needed basis. The MOU has been reviewed by bot the Town of Estes Park attorney and the fire districts attorney. NO issues noted by the board.

Motion by Larry Leaming, seconded by Dave Hamrick to approve the MOU for use of the restorative justice program. Motion carried unanimously.

Fire Inspector Hiring Process

- Received applications from 5 candidates
- Interviewed 4 candidates (one dropped due to housing costs)
- Very strong candidates, exceeding our minimum requirements
 - Plan to offer one candidate the open Inspector position, within budgeted salary
 - Requesting Board permission to offer second candidate an Inspector position
 - Had planned to put second Inspector in 2022 budget, but had strong candidates
 - With Mutzl working 0.33 FTE and onboarding in August for both, would total to 1 FTE for year – within adopted 2021 budget
 - Space solution able to work existing space to reframe and seat all employees

The board approved hiring two fire inspectors. No vote needed as it was within this year's budget.

University Service Agreement for WUI Home Inspections

Chief Wolf presented to the board an agreement to utilize CSU for WUI home assessments while we work to hire a fire inspector. We are also utilizing Larimer County EM. This is a temporary agreement.

Motion by Dave Hamrick, seconded by Jon Hodde to approve the CSU agreement for WUI home assessments. Motion carried unanimously.

CO Special District P&LP Repayment Agreement

A repayment agreement was brought to the board as part of the CO Special District P&LP as a participant in the cancer benefit trust/cancer award program. There is no repayment needed as long as we have our workers compensation with the pool, which we do currently. We have no reason for that to change.

Motion by Jon Hodde, seconded by Ed Ford to sign the repayment agreement. Motion carried unanimously.

The next regularly scheduled board meeting will be Wednesday July 28th, 2021 at 5:30 p.m.

President Richardson took a moment to read the following on record at the meeting: This last Sunday marked five years that Chief Wolf has been leading our organization. We have seen many changes under his leadership and most recently he led us through the two largest wildfires in Colorado history during a worldwide pandemic. Chief Wolf continues to represent our district through his involvement as chair of the Volunteer & Combinations Section of the Colorado State Fire Chiefs' Association and as a committee member for Residential Size Up and Search & Rescue with the UL Firefighter Safety Research Institute. He has been a featured speaker for many local organizations including the Estes Chamber of Commerce, Board of Realtors, and the Sunrise Rotary. He facilitates the conversations with EP Ambulance, EPPD, dispatch, ToEP Administrator, board members, and members to work through issues and processes for continuous improvement. There are only 24 hours in a day. Between writing policy, budgeting, grant writing, training, keeping up on trends, meetings, responding to calls, and his family; we just don't know how he does it!

The board acknowledged and thanked Chief Wolf for his service and leadership.

The board requested that notice be posted that there will be a quorum of the board at our July 4th social event, but no actions will take place.
