Moved by Mike Richardson, seconded by Mike Kearney to approve the agenda as written. Motion carried unanimously.

APPROVAL OF MINUTES

Moved by Mike Richardson, seconded by Dave Coleson to approve the 8/28/19 meeting minutes as written. Motion carried unanimously.

Presentations – 2020 Budget

Highlight of changes for the 2020 budget:

REVENUES

- Sales tax increase of \$47,011 (4%) over 2019
- Property tax increase of \$93,928 over 2019, due to increased valuations
- Specific ownership tax increase of \$7,045
- Plan Review & Inspection fee decrease of \$35,000
- Impact fees no change
- Training Division revenue increased of \$5,000
- Other revenue decrease of \$70,000, without sale of apparatus
- NET CHANGE, increase of \$47,984

SALARIES AND BENEFITS

- Discussion later on agenda for updated salary ranges
- Proposed salaries assume approval of updated range
- 2020 assumes that 2019 CPI is 3%, which is statistically high

INSURANCES

- Increases of 3.5% increases on medical, 0% on Dental, 0% on Vision
- 2020 Budget assumes changes from employee only to family plan

Motion by Doug Klink, seconded by Mike Richardson to allow Chief Wolf to dispose of L6 as he sees fit including donation to a worthy agency. Motion carried unanimously.

NEW BUSINESS

Chief Wolf presented an IGA for Disaster-Emergency Mutual Aid and Funding Assistance. This IGA has already been put in place with other emergency service agencies in Larimer County. Motion by Ed Ford, seconded by Mike Kearney to approve the IGA for Disaster-Emergency Mutual Aid and Funding Assistance. Motion carried unanimously.

Chief Wolf presented the updated active membership policy. This was brought to the board on 8/28 and now is up for vote. Motion by Dave Coleson, seconded by Ed Ford to approve the update to the active membership policy for an effective date of 1/1/2020. Motion carried unanimously.

Chief Wolf presented a proposed policy update to the Districts ride-a-long policy. The new proposal adds items such a photo & social media limitation to further protect the district from liability. This will be up for vote at the 10/16 board meeting.

At 7:33 a motion was made by Doug Klink, seconded by Dave Coleson to move into executive session pursuant to "section 24-6-402 (4)(f) C.R.S. for purposes of discussing a personnel matter regarding salary." Motion carried unanimously.

Regular session resumed at 8:08pm.

Chief Wolf presented the proposed update to salary ranges. Job title Fire Captain was removed. This will be brought to the board for a vote on 10/16/19.

The next regularly scheduled board meeting will be October 16, 2019 at 6:00 p.m. at Dannels Fire Station.

There will be a board retreat held on October 21st from noon -5pm at Statin 1.
