## **Volunteer Assistant Fire Chief Report -**

Chief Landkamer wanted to recognize our members who have recently been hired by paid departments. Rachel Hofsess hired by West Metro and Katie Averdick hired by Poudre Fire. Six new candidates have been brought on with the possibility of a couple more. Of the six, 2 intend to do interior and the remaining 4 will do exterior academy.

<u>Treasurer's Report-</u> Jon Hodde reviewed the April 2021 balance sheet(s) including, but not limited to: governmental funds and schedule of capital assets, statement of revenues, expenditures, and changes in fund balance for general operations, operating reserve, Tabor and capital reserve were also provided. Sales tax projections were discussed. Moved by Ed Ford, seconded by Dave Hamrick to accept paid bills. Motion carried unanimously.

#### **Extension of COVID-19 Disaster Declaration**

While we are operating under a disaster declaration the board needs to formally extend the order at each board meeting.

Motion by Larry Learning, seconded by Ed Ford to extend resolution 20-02 continuation of declaration of local disaster emergency. Motion carried unanimously.

#### **NEW BUSINESS**

## Resolution 2021-01 Update to Prevention Fee Schedule

Chief Wolf presented to the board the proposal to update the fee schedule to reflect a lower fee for explosives and blasting based on community feedback. Discussion took place. This update will affect two customers currently. Fee update to be effective June 1<sup>st</sup>, 2021. Jon Hodde wanted to thank the prevention division on coming up with a solution and working with the affected businesses.

Motion by Ed Ford, seconded by Jon Hodde to approve resolution 2021-01 to update the prevention fee schedule. Motion carried unanimously.

#### **IGA- Wilding Deployment Resource Sharing**

Chief Wolf presented an IGA for wildland deployment resource sharing. This would be an agreement that would allow our member(s) to fill a seat on a rig for deployment by another agency if needed. There are currently about a dozen agencies using this IGA. This does not commit our resources but could be used on an as needed basis. This is for personnel only, not apparatus.

Motion by Dave Hamrick, seconded by Larry Learning to approve the IGA for wildland deployment resource sharing. Motion carried unanimously.

#### First Review of Update to Policy #301 – Active Membership Policy

Chief Wolf presented to the board a recommendation to update the active membership policy to include apparatus checks. This update was brought by the officer group and has their support. In 2021 the annual apparatus check requirement will be prorated due to the expected effective date of 7/1/2021. No issues brought by the board. It was clarified that apparatus checks do earn training credit.

## First Review of Update to Policy #305 - Emergency Driving Policy

Chief Wolf presented to the board a recommendation to update the emergency driving policy to add a section for backing. This was determined to be a best practice and to help mitigate preventable accidents. No issues brought by the board. Chief Wolf outlined the requirements to receive lights and sirens for emergent driving at Hodde's request.

## **Discussion of Residential Sprinkler Regulations**

A local contractor brought the issue of residential sprinklers to the attention of President Richardson. Division Chief Sullivan and Chief Wolf prepared information for the boards review to explain when residential sprinklers would be required. Chief Wolf reviewed that the code requires access and water supply and if these cannot be met, then sprinklers are an approved alternative means. President Richardson relayed the contractors concerns of communicating these requirements to the builders. President Richardson expressed that he reviewed these requirements to the contractor and advised the contractor of the grievance procedure. Discussion took place with all agreeing that the code is the code and that the requirements are reasonable. Of the residential properties needing sprinklers they represent less than 25% of plans reviewed.
