Treasurer's Report- Dave Coleson reviewed the July 2019 balance sheet(s) including, but not limited to: governmental funds and schedule of capital assets, statement of revenues, expenditures, and changes in fund balance for general operations, operating reserve, Tabor and capital reserve were also provided.

OLD BUSINESS

Dispatch:

Station Transfer:

- Building Transfer

 - Unable to do building from Town via Bill of Sale (Linda still looking into this)
 - Must include in public vote
 - Recommend waiting for Spring general election, no cost to District

 - Our current status

- Who are we? *Sent out 5/31/2019*
 - I want to do a series of surveys to compile
 - Mission/Vision/Values
 - Non-negotiables
 - What makes Estes Valley, Estes Valley?
 - What do we want people who join to know about who we are?
 - Survey to members, Board, community members
 - Participation
 - Board Members: 2 of 5 = 40%
 - Staff: 4 of 4 = 100%
 - Volunteers: 17 of 38 = 45%

 - A series of surveys probably a month or so later

 - How will residents change?
 - How will visitation change?
 - How will our finances change?

 - How will this impact our call volume/demand?
 - Participation

 - Staff: 4 of 4 = 100%
 - Volunteers: 15 of 38 = 39%
- Members' planning session Tuesday August 27, 19:00
 - Productive discussion about challenge and values
 - Largest challenge is consistency
 - When we get enough people, we have the training and equipment to accomplish
 - Getting enough people is variable
 - Q3 2019 - 3 calls reported as inadequate resources
 - Q1 & Q3 2018 3 calls each quarter reported as inadequate

 - Discussed ideas, pros/cons
 - Public education about expectations

RECORD OF PROCEEDINGS

Discussion took place on setting up a board retreat to work on strategic planning. Retreat is tentatively set for October 21st at noon.

NEW BUSINESS

Chief Wolf presented the updated active membership policy. This has already been brought to the officers and the membership for input. Biggest change is making the annual call requirement a flat 45 calls per year instead of a percentage. Training hours have been set at 72 hours annually. Excess training conversion was eliminated. Cell phone reimbursement program added. This will be brought to the board for approval at the September 25th meeting.

Office Manager Erika Goetz proposed following the change to posting requirements as allowed by HB 19-1087. This bill allows for removing the physical posting of notices as long as they are available for free to the public on the Districts website. Our website has been updated with DOLA and we are set up to post on our website. Board agrees with this change. We will communicate this change to the public on our website, newsletter, and updated posting at our physical location.

The next regularly scheduled board meeting will be September 25, 2019 at 6:00 p.m. at Dannels Fire Station.
