Outcomes:

Administrative

- Maintain an Operating Reserve of at least 25% of annual Operating Budget
- Target combined Operating & Capital reserves of at least 33% of annual Operating Budget
- Recession plan
- Maintain a Capital Reserve and Capital Budget to enable:
- Replacement of heavy apparatus every 20 years
- Replacement of support vehicles every 10 years
- Provide our members with services/benefits to promote mental health & physical wellbeing
- Update and maintain organizational policies
- Ongoing development of effective and efficient business processes
- Promote strategic and responsible use of resources
- Maintain high standard of transparency and responsibility to the public

Prevention

- Inspection plan to visit every commercial occupancy in the Estes Valley at least every two years
- Complete plan reviews and requests for comment by assigned deadlines 90% of the time

Training & Operations

- Build and maintain mutual aid networks and partnerships to enhance operational readiness (aid in closest available resource dispatching)
- Explore feasibility of unifying/merging with adjacent Districts/Departments
- Consistency of response / response times?
- Increase recruitment efforts, Aim for 40-45 volunteer members
