 - Issues identified in pump testing scheduled for work in Estes (mobile mechanic)

Cameron Peak Fire:

- 1) 08/13 Fire started, with Estes units responding on initial attack under mutual aid
- 2) 09/05 Fire threatens Rocky Mountain National Park. Started attending meetings with Incident Management Team (IMT) and Rocky Mountain National Park (RMNP).
- 3) 09/06 Became embedded with IMT to support Estes Valley interests
 - Ensured that IMT and other partners were aware of values at risk in the Estes Valley
 - Provided local intel to Division Supervisors and Branch Chief for terrain, holding features
 - Provided all preparatory work done to date that could add value:
 - i. Wildfire modeling and response plan, built in 2017
 - ii. Community Evacuation Plan, built in 2018
 - iii. Fuel models and wildfire risk assessment, built in 2018
 - iv. Detailed GIS maps of district with pertinent features, built in 2018
 - v. Community Wildfire Protection Plan, updated 2019
 - Served as liaison for the Estes Valley to IMT. Collected and communicated concerns from numerous local agencies.
 - i. Estes Park Police Department / Emergency Management
 - ii. Estes Park Health
 - iii. Glen Haven Fire
 - iv. Loveland Fire Rescue Authority
 - v. Private landowners to arrange land use agreements for line construction, drop points, landing zones, and helicopter fill sites
 - Maintained communications for Estes Valley Fire
 - i. Daily updates to agency to all members and Board
 - ii. Communicate with Officers about potential needs
 - Increased public messaging
 - i. Informational flyers in English and Spanish on website (completed by Prevention)
 - ii. Updated Town electronic message boards about drones

 - Presented to Town Board

Extension of Disaster Declaration

While we are operating under a disaster declaration the board needs to formally extend the order at each board meeting.

Motion by Larry Learning, seconded by Mike Richardson to extend resolution 20-02 continuation of declaration of local disaster emergency. Motion carried unanimously.

NEW BUSINESS

Approval of Proposed Change to Policy #306 Battalion 71 On Call Program

Chief Wolf presented policy #306 Battalion 71 On Call Program to the board at the 8/26 meeting. Motion by Mike Richardson, seconded by Larry Learning to allow policy #306 to be changed from a policy to a SOG. Motion carried unanimously.

2021 Budget Presentation

Chief Wolf presented a PowerPoint to the board outlining the proposed 2021 budget by division noting significant increases and/or decreases in each division. No significant issues were raised by the board.

Resolution 2020-03 Support for Colorado Amendment B

Chief Wolf presented a proposed resolution showing support for Colorado Amendment B to the board. Motion by Mike Richardson, seconded by Larry Learning to approve resolution 2020-03 to support Colorado Amendment B. Motion carried unanimously.
