APPROVAL OF MINUTES

NEW BUSINESS

Chief Wolf presented the Board with an updated job description for the Fire Marshal, a job posting notice, and written assessment to be included with the application. Chief Wolf asked the Board to approve a salary range of \$70,000-\$90,000 to be used in the job posting. This salary is in line with the proposed update to the salary ranges to be presented next.

Moved by Mike Richardson, seconded by Ed Ford to approve a salary range of \$70,000-\$90,000 for the Fire Marshal job posting. Motion carried unanimously.

Chief Wolf presented a proposed update to the salary ranges for paid staff as stated in the Financial Policy Manual. The current salary ranges need to be updated to keep in line with cost of living increases, to remain competitive, and to include all job titles.

Administrative Assistant to be removed and replaced with Office Manager \$45,000-\$65,000.


Add Fire Inspector at \$40,000-\$60,000.

Change Training Captain to Fire Captain at \$55,000-\$75,000.

Update Fire Marshal to \$70,000-\$90,000.

The job posting for Fire Marshal will be posted Friday August 18th to be distributed through the Colorado State Chiefs, Colorado State Fire Marshals, and Colorado State Training networks.

The next board meeting is scheduled for August 23, 2017 at 6:00p.m. at Dannels Fire Station.
