President Klink informed the board that the pension actuarial has been completed and we will need to meet as a pension board to discuss. President Klink will email Milliman and ask for numbers to see how the State contribution would change if we were to raise the monthly pension benefit.

#### **NEW BUSINESS**

A motion was made by Mike Richardson, seconded by Mike Kearney to approve the social media and photo policy as reviewed on 6/12 & 7/24. Motion carried unanimously.

A motion was made by Ed Ford, seconded by Mike Richardson to approve resolution 2019-04 to amend the 2018 budget. Motion carried unanimously. This was needed to properly account for the down payment of the new ladder truck.

President Klink asked the board if they had reviewed the 2018 audit as prepared by Dazzio and Associates. The audit was "unremarkable".

A motion was made by Dave Coleson, seconded by Mike Kearney to accept the 2018 audit by Dazzio and Associates. Motion carried unanimously. Erika Goetz to give Steve Dazzio the ok to file the audit.

Chief Wolf read a letter from Division Chief John Jerome recommending a waiver of plan review and impact fees to the Estes Park High School. A letter from Principal Chuck Scott requesting the fee waiver was available for review as well. Discussion followed.

A motion was made by Mike Richardson, seconded by Mike Kearney to approve the plan review and impact fee waiver for the Estes Park High School. 4-yes, 0-no, 1-Recused from vote

Chief Wolf and President Klink would like to move forward with starting the process to sell Squad 3. The new ladder truck will replace current ladder 6 and squad 3. Squad 3 would be most likely be available at the end of October for pick up, once the new ladder is in service. A motion by Mike Kearney, seconded by Dave Coleson to approve the sale of squad 3 for a net sale of no less than \$70,000 by Chief Wolf and/or President Klink without further approval of the board. Motion carried unanimously.
